

VR Transpoint Road logistics freight price determination and price list for supplementary services 2024

VR-Group Plc road logistics's terms of delivery freight price determination and price list for supplementary services will enter into force on 1 January 2024 and remain in force until further notice. The prices will replace the prices valid as of 27 September 2022. Value added tax is not included in the prices.

Freight price determination The freight price is affected by the transportation distance transported and the freight weight of the shipment. The shipper must record the following information on each shipment in the waybill for the purpose of defining the freight weight:

- gross weight and dimensions: length, width and height
- volume weight 333 kg/m³, measured at container clearance
- load metre weight 1,850 kg/load metre

The largest of these three cargo weights is used.

The customer must provide all necessary information about the shipment. The customer is also responsible for ensuring that the information they provide is correct.

Transport documents The customer/shipper must provide a waybill or an electronic waybill for each shipment and equip each container with an address label, if necessary, in accordance with the standard. Waybill numbering must comply with the specified SFS standard.
